

# Two TRS Bills Pass the 68th Montana Legislature

### HB 117: Generally Revise Working Retiree Laws Under TRS

This bill was introduced at the request of the Teachers' Retirement Board to provide more flexibility for TRS employers to fill vacant positions with retired TRS members.

Previously, retirees who returned to TRS-reportable employment could continue to receive their full montly retirement benefit as long as their earnings in that fiscal year did not exceed the greater of one-third of their Average Final Compensation (AFC) or one-third of the median AFC for all members who

retired in the previous fiscal year. Effective July 1, 2023, the annual earnings limitation will increase from one-third to 49% of AFC.

The Internal Revenue Service (IRS) requires the employment relationship to be completely severed before TRS can begin paying monthly benefits to a retiring member. In addition, before that retiree may again provide service in a position reportable to TRS, the employer must certify that there has been a *bona fide separation from service* (a break in service), the length of which is defined by the retirement system. Effective January 1, 2024, HB 117 shortens this required break in service from 150 to 120 calendar days for TRS members who terminate employment on or after that date and retire.

### **HB 135: Revise Administrative Provisions of TRS**

This TRS "housekeeping bill" also was introduced at the request of the Teachers' Retirement Board to clarify and provide technical fixes within several sections of statute. The provisions modified by HB 135 are administrative in nature and do not affect your rights or benefits as an active or retired TRS member.

# Interest Rate to Increase July 1

Did you know TRS pays monthly interest on active and inactive (non-retired) members' account balances? A member's account consists of all TRS contributions withheld from their pay, plus interest.

Effective July 1, 2023, the annual interest rate credited to member accounts will increase to 4.00%, the highest rate since 2007. State law requires the TRS Board to adjust the interest rate each year. Typically, they set the rate based upon the short-term investment rate earned by the Montana Board of Investments.

As a reminder, your member contributions and interest remain on account with TRS until you terminate all TRS-reportable employment and either apply for a monthly retirement benefit or withdraw your account balance.

# What Are "Required MInimum Distributions" (RMDs)?

You might be aware that the IRS requires people to begin taking distributions from their tax-advantaged retirement accounts when they reach a certain age.

If you still work in any position reportable to TRS, then this rule does not apply to your TRS account, even if you are in your seventies. However, once you terminate TRS-reportable employment, be sure you either apply for a retirement benefit or withdraw your account balance before you reach your RMD age.

# Meet With TRS Staff at the Annual MFPE Educator Conference

Current Educators: Do you plan to attend the annual Montana Federation of Public Employees (MFPE) Educator Conference in Billings this fall? TRS will be there and we hope to see you at our booth and in our popular in-person presentations. Here's a brief summary of our planned conference activities:

- Our "TRS 101: Retirement System Basics" presentation is designed for early- and mid-career members but it can serve as a helpful refresher for any member. In this session, you'll learn how TRS works, what it means to be "vested," and when Tier 1 and Tier 2 members become eligible for retirement benefits.
- Members nearing retirement age should attend our "Ready, Set, Retire!" presentation to learn how to make important retirement decisions and apply for a monthly benefit. This session is a must for any member who is eligible (or nearly eligible) to retire as a TRS Tier 1 or Tier 2 member.
- Members attending the conference who are planning to retire in the next 3-5 years will have an opportunity to schedule a private counseling session with a TRS Benefit Officer during the event. Watch for details in MFPE's conference registration materials if you want to reserve your spot.

## **BOARD and STAFF UPDATES**

At the Teachers' Retirement Board meeting held May 5, 2023, members bid a fond farewell to member **Scott Dubbs**, whose final term ends July 1, 2023 after five appointments and 24 years of continuous service to the Board.

# Board Departures

Governor Marc Racicot initially appointed Mr. Dubbs to the Teachers' Retirement Board by in August 1999. At that time, Mr. Dubbs had been a member of the School Administrators of Montana (SAM) board for six years. All told, his service on school-related boards spans a remarkable 30 years.

Chairperson Kari Elliott presented Mr. Dubbs with a plaque and thanked him for his kindness and dedication to Montana educators, noting the countless times he has driven from Lewistown to Helena for board meetings over the years.

TRS Executive Director Shawn Graham expressed appreciation for Mr. Dubbs' calm, measured approach to board decisions. His knowledge and experience as a school administrator have been invaluable, such as when helping TRS to navigate complex IRS restrictions on post-retirement employment over a decade ago.

TRS Chief Legal Counsel Denise Pizzini credited Mr. Dubbs with helping to reduce the number of contested case matters in recent years, in part by advising TRS on school district hiring practices and contract negotiations. As a member of the Board's Legislation and Litigation committee, Mr. Dubbs has played an important role in clarifying both statutory language and internal TRS practices over the years.

Deputy Director Tammy Rau also noted the critical role Mr. Dubbs has played in expanding TRS staff and investing in better technology as times have changed. Such improvements allow TRS to maintain a high level of service to members and employers. Mr. Dubbs' institutional knowledge will be greatly missed.

"A lot has changed, of course, since 1999," Mr. Dubbs said. "It has truly been an honor."

**Sarah Hitchcock**, appointed to the Teachers' Retirement Board by Governor Gianforte in 2021, resigned from her Glasgow teaching position in January 2023 to accept a job with the Office of Governor Kristi Noem of South Dakota. We thank Ms. Hitchcock for her service and wish her success in her new role.
